- The application is made under the Town and Country Planning Act 1990, sections 78, 322 and Schedule 6, and the Local Government Act 1972, section 250(5).
 - The application is made by Mr M Anderson for a full award of costs against Elmbridge Borough Council.
 - The appeal was against the refusal of planning permission for the change of use of part ground floor and first floor to provide 3no. additional flats, single-storey rear extension with associated bin and cycle stores and rear pedestrian access from South Road with 1.8m high fencing and 1.8m gate for Flat 1.

Decision

1. The application for an award of costs is refused.

Reasons

2. Planning Practice Guidance (PPG) advises that irrespective of the outcome of the appeal, costs may only be awarded against a party who has behaved unreasonably and thereby caused the party applying for costs to incur unnecessary or wasted expense in the appeal process.
3. I note the applicant has referred to alleged unreasonable behaviour of the Council with respect to inadequate reasoning; a decision contrary to professional advice; incorrect references to out of town development; failure to take into account other decisions; and permission should have been granted.
4. However, the Council was not obliged to agree with the applicant's views in making its decision. Nor was it obliged to agree that there were any material considerations outweighing any conflict identified by them. There is no substantive evidence before me which demonstrates that the appeal scheme was not properly assessed by the Council, or that the conclusion stated in the Decision Notice was reliant on baseless concerns. I am satisfied adequate reasoning has been provided as to why planning permission was refused. There is no evidence of demonstrable unreasonable behaviour of the Council.
5. I therefore find that unreasonable behaviour resulting in unnecessary or wasted expense, as described in the PPG, has not been demonstrated. Therefore, the applicant's claim for costs fails.
